\*Assumptions made in projecting a contingency budget for the 2017-18 school year, should the proposed budget be defeated pursuant to Section 2023 of the Education Law, would result in reductions in equipment purchases of \$44,505 and non-represented salaries of \$25,383. The contingency budget could be further reduced, depending on the Board of Education’s discretionary use of district reserves to mitigate a 0 percent increase in the 2017-18 tax levy. Without the use of additional reserves, the contingency budget for the 2017-18 school year would be further reduced by \$290,805 to \$34,031,807.
